ASSIGNMENT OF TRADEMARKS

- 2. Assignor hereby represents that it has the full right to convey the Registered Marks to Assignee and this Assignment is effective to transfer all of Assignor's right, title and interest in the Registered Marks to Assignee.
- 3. Assignor hereby covenants and agrees to execute any and all documents reasonably requested by Assignee for the purpose of carrying out the intent and purposes of this Assignment. Assignor hereby further covenants and agrees that it will cooperate with Assignee to enable Assignee to enjoy, to the fullest extent, the right, title and interest intended to be herein conveyed. Assignor's cooperation shall include prompt production of pertinent facts and documents, giving of testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance relating to the Registered Marks, all to the extent deemed necessary or desirable by Assignee for participation in any legal or administrative proceedings involving the Registered Marks, and otherwise fully carrying out the terms of this Assignment.


