**TRADEMARK ASSIGNMENT AGREEMENT**

**THIS TRADEMARK ASSIGNMENT AGREEMENT** is made and entered into as of November 21, 1997 by and between **BOLLINGER INDUSTRIES, INC.**, a Delaware corporation ("Assignor") and **HEDSTROM CORPORATION**, a Delaware corporation ("Assignee").

**WHEREAS**, Assignor is the owner of certain tradenames, trademarks, service marks, trademark registrations and applications, service mark registrations and applications, trade dresses, logos, designs and slogans, in word mark, stylized and/or design formats, including, without limitation, those which are the subject of the registrations identified on Schedule I hereto (the "Marks");

**WHEREAS**, Assignor and Assignee have entered into that certain Asset Purchase Agreement dated as of November 13, 1997 (the "Asset Purchase Agreement"), pursuant to which Assignor has agreed to sell and assign to Assignee, and Assignee has agreed to purchase and accept from Assignor, all of Assignor's right, title and interest in and to the Marks; and

**WHEREAS**, this Trademark Assignment Agreement shall effectuate such assignment of the Marks.

**NOW, THEREFORE**, for good and valuable consideration, including, without limitation, the mutual covenants and agreements set forth in the Asset Purchase Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee all of its right, title and interest throughout the world in and to the Marks, including, without limitation, the registrations pertaining thereto, together with the goodwill of the business symbolized by the Marks and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Assignor in all matters related thereto.
