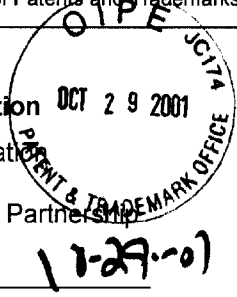

NUNC PRO TUNC ASSIGNMENT OF SERVICE MARK


