**NUNC PRO TUNC ASSIGNMENT**

On September 3, 1987, Financial Capital Investment Company, a California corporation with its principal place of business at 11859 Wilshire Boulevard, Los Angeles, California 90025 ("Assignor"), entered into an Agreement of Purchase and Sale with MS West Hollywood Limited Partnership ("MS West") in which MS West assigned certain assets to Assignor, including the trademark ARGYLE and U.S. Trademark Registration No. 1,935,192 thereof, together with the goodwill symbolized by the mark ("the Trademark").
