ARTICLE I. The name of the Corporation is Interealty Corp.

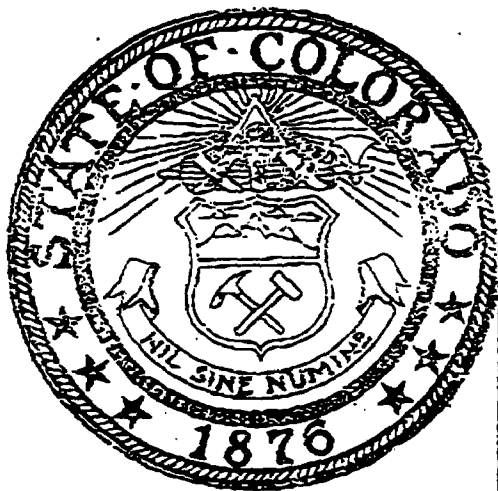
