For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Reed Elsevier Inc., a Massachusetts corporation having its principal place of business at 125 Park Avenue, New York, New York 10017 (the "Assignor"), does hereby sell, assign and transfer to Travel Newco LLC, a Delaware limited liability company having its principal place of business at 500 Plaza Drive, Secaucus, NJ 07094 (the "Assignee"), its successors, assigns and legal representatives, the entire right, title and interest of Assignor in and to all trademarks, trade names, trade dress, service marks, logos and business names of Assignor which are used exclusively in connection with Assignor's business of (a) publishing directories and magazines for the travel and meeting planning industries and for travel and meeting planning professionals and (b) compiling, maintaining and licensing databases of travel-related information, including, but not limited to, the trademarks identified on Schedule A hereto (collectively, the "REI Trademarks"), and the goodwill related thereto, and all registrations and applications for registration of all of the foregoing, including any renewals and extensions of the registrations that are or may be secured under the laws of the United States and all other countries, whether now or hereafter in effect, for Assignee's own use and enjoyment, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment and sale had not been made in the United States and other countries, and all rights, powers, emoluments, and advantage whatsoever symbolized thereby of Assignor, including common law rights in the REI Trademarks, and all rights to sue for and obtain damages, injunctive relief and attorneys' fees for all past infringements with respect thereto both at common law and under the statutes of the United States or any other country now or hereafter in effect, and claims and causes of action in favor of the Assignor heretofore accrued or hereafter accruing with respect thereto for misappropriation, infringement or other violation of proprietary or other rights in the REI Trademarks and all registrations or applications relating thereto and all renewals and extensions of such registrations. Assignor requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner thereof.

TO HAVE AND TO HOLD the same unto the Assignee, its successors and assigns, for and during the existence of such REI Trademarks and all renewals and extensions thereof, as fully and as entirely as the same would have been held and enjoyed by the Assignor had this Assignment and transfer not been made.





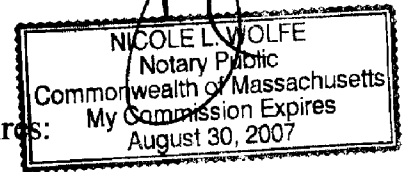
