ARTICLES OF MERGER  
OF  
OMARK INDUSTRIES, INC.  
(an Oregon corporation)  
AND  
BLOUNT, INC.  
(a Delaware corporation)

In accordance with the provisions of Section 57.495 of the Oregon Business Corporation Act, Omark Industries, Inc., an Oregon corporation and Blount, Inc., a Delaware corporation, adopt the following Articles of Merger for the purpose of merging Omark Industries, Inc., an Oregon corporation, into Blount, Inc., a Delaware corporation:

1. The plan of merger approved by the corporations is as set forth in the "Agreement and Plan of Merger," a copy of which is attached hereto as Exhibit A and made a part hereof.

2. The name of the surviving corporation is Blount, Inc., and it is to be governed by the laws of the State of Delaware.

3. Omark Industries, Inc., an Oregon corporation, has issued and outstanding 3,991,521 shares of its Class B common stock, no (\$0.00) par value per share. All of the outstanding Class B common stock is owned by Blount, Inc. There are no other shares of capital stock of Omark outstanding.

4. Blount, Inc., the sole shareholder of Omark Industries, Inc., has waived the mailing of a copy of the plan of merger to the sole shareholder.

5. The merger of Omark Industries, Inc. into Blount, Inc. shall become effective as of the close of business on February 28, 1987.

6. Blount, Inc. hereby acknowledges that it may be served with process in the State of Oregon in any proceeding for the enforcement of any obligation of Omark Industries, Inc. and any proceeding for the enforcement of the rights of the dissenting shareholder of Omark Industries, Inc. against Blount, Inc. as the survivor of the merger described herein. Blount, Inc. hereby irrevocably appoints the Corporation Commissioner of the State of Oregon as its agent to accept service of process in any such proceeding. Blount, Inc. acknowledges that it will promptly pay to the dissenting shareholders of Omark Industries, Inc. the amount, if any, to which they shall be entitled under the provisions of the Oregon Business Corporation Act with respect to the rights of dissenting shareholders.

IN WITNESS WHEREOF, Blount, Inc., as the surviving corporation and the sole shareholder of Omark Industries, Inc. has duly caused these Articles of Merger to be executed by its duly authorized officers as of this 16TH day of February, 1987.
