ASSIGNMENT

THIS AGREEMENT is made and entered into this 22nd of October, 2001, by and between TRANSAMERICA CORPORATION, a corporation organized under the laws of the state of Delaware, with its principal place of business at 4333 Edgewood Road, N.E., Cedar Rapids, Iowa 52499 ("TAC") and TRANSAMERICA REAL ESTATE TAX SERVICE, INC., a corporation organized under the laws of the state of Delaware, with its principal place of business at 1201 Elm Street, Suite 400, Dallas, Texas 75270 ("TRETTS").

RECITALS:

WHEREAS, TAC and American Security Insurance Co., a corporation organized under the laws of Delaware, located and doing business at 260 Interstate North Circle, N.W., Atlanta, Georgia 30339-2111 ("ASIC"), are joint owners of all right, title and interest in and to the service mark INUNISYN and pending application Ser. No. 75/916,304 – INUNISYN, filed in the United States Patent and Trademark Office on February 11, 2000, hereinafter referred to collectively as the "Mark."

WHEREAS, TAC desires to transfer all of its right, title and interest in and to the Mark to TRETTS and TRETTS desires to acquire all of TAC's right, title and interest in and to said Mark.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. TAC hereby assigns to TRETTS all of its right, title and interest in and to the Mark, together with the goodwill associated therewith. TAC and TRETTS are related companies, and TRETTS provides that portion of the services to which TAC's interest in the Mark pertains as required by the document captioned "Combined Services Agreement," executed by and among TRETTS, ASIC and Standard Guaranty Insurance Company, a Delaware corporation, as of June 17, 1999. TAC's assignment to TRETTS of all its right, title and interest in and to the Mark.

including pending application Ser. No. 75/916,304, filed pursuant to Section 1(b) of the Trademark Act, 15 U.S.C. 1051(b), does not conflict with the provisions for assigning applications based on Section 1(b) as contained in Section 10 of the Trademark Act, 15 U.S.C. 1060.

2. TAC agrees to take any and all additional actions and to execute any and all additional documents that are necessary to implement and record this Assignment.

3. The effective date of this Assignment shall be the date on which this document is fully executed by the parties.
