

PURSUANT TO THE PROVISIONS OF SECTION 805 of the Business Corporation Law, the undersigned corporation executes the following Certificate of Amendment to its Certificate of Incorporation:

- 1. The name of the corporation (hereinafter called the "Corporation") is: Salmor Import Export Corp.
- 2. The Certificate of Incorporation of the Corporation was filed by the Department of State of the State of New York on February 17, 1981.
