



TRADEMARK ASSIGNMENT

WHEREAS, AFE LEVAGE CORPORATION, a corporation of France, 1 rue Andre Compain, 08800 Montherme, France ("Assignor"), has filed an intent-to-use application with the United States Patent and Trademark Office (the "PTO") for the mark SEFAC (Serial Number 76/193,570) for use in connection with heavy garage equipment, lifting equipment, roller bridges, electromechanical hoists and lifts for vehicles, motorized hydraulic elevator tables, components hydraulics elevators; jacks for vehicles; wheels removal; spring presses, namely, machines for industrial purposes, extraction presses, namely, machines for industrial purposes, machine shop cranes, namely, lifting and hoisting apparatus (the "Mark");

WHEREAS, Triapt Holdings Limited ("Assignee"), a corporation of the United Kingdom with offices at Overton Farm, Snaps Lane, Snelston, Ashbourne, Derbyshire, United Kingdom, is a successor to Assignor's business pursuant to 15 U.S.C. § 1060;

WHEREAS, the purpose of this Trademark Assignment is to confirm Assignee's purchase of substantially all of the assets of Assignor, pursuant to an Asset Purchase Agreement dated April 16, 2001, and to memorialize and effect the transfer of the Mark to Assignee in accordance with the Asset Purchase Agreement;

WHEREAS, pursuant to the Asset Purchase Agreement, Assignee acquired any and all rights that Assignor may have had in and to the Mark and the pending application therefor, together with the goodwill of the business symbolized by the Mark, along with the right to recover for damages and profits for past infringements thereof;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby confirms the assignment and transfer to Assignee of all right, title, and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, and the pending application thereof, along with the right to recover for damages and profits for past infringements thereof.
