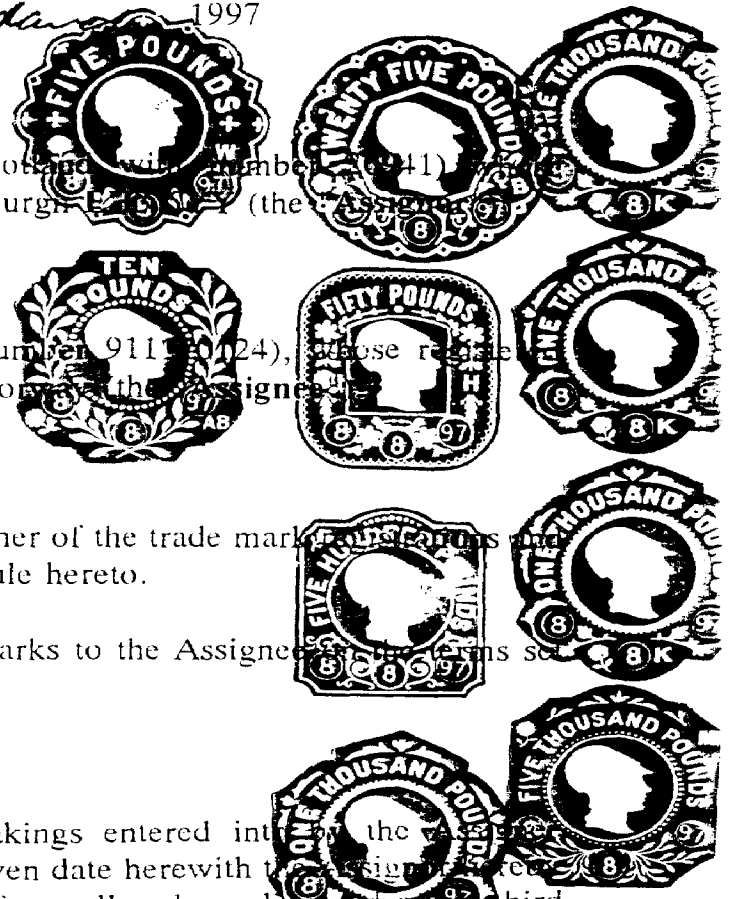
WHEREAS

- The Assignor undertakes that at the request and expense of the Assignee it will do all acts and things (including, without limitation, making declarations and oaths) and execute all deeds, documents, papers, forms and authorisations or do any other thing that may be reasonably necessary under the law of any country for securing, completing, further assuring or absolutely vesting in the Assignee full right, title and interest to any of the rights assigned by Clause 1 hereof.
- This Assignment (together with all documents referred to herein) shall be governed by and construed and shall take effect in accordance with English law and the parties hereby submit to the exclusive jurisdiction of the English Courts.




