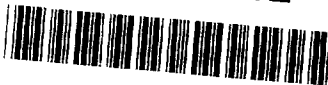

## TRADEMARK RELEASE OF SECURITY INTEREST

This instrument is executed on the date of acknowledgement, but to be effective as of the 31st day of December, 2001 by Shawmut Equity Partners, L.P., a Delaware limited partnership, with its head office at 75 Federal Street, 18th Floor, Boston, Massachusetts 02110 (the "Creditor").

WHEREAS, bTrade, Inc. (formerly known as bTrade.com, Inc.) WHEREAS, the Creditor desires to terminate and release the security interest in the Trademarks held by the Creditor for the benefit of the Creditor.



the present and future rights in, to and associated with the Trademarks throughout the world whether arising under federal law, state law, common law, foreign law or otherwise, to use the Trademarks for the benefit of the Grantor.
