

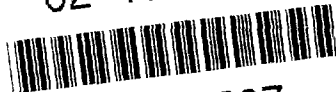

ASSIGNMENT OF TRADEMARK


