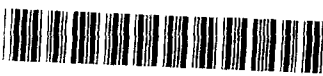



WHEREAS Assignor is assigning the mark in the above-identified Application as part of the entire business to which the mark pertains as required by 15 U.S.C. Section 1060; and


