Said amendment was duly adopted by the Board of Directors without shareholder action in accordance with Section 14-2-1002(8) of the Georgia Business Corporation Code.

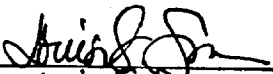

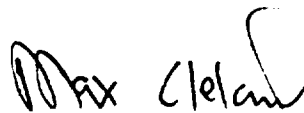

ARTICLES OF INCORPORATION  
OF  
UNIVERSAL WRESTLING CORPORATION

The Articles of Incorporation of UNIVERSAL WRESTLING CORPORATION are as follows:

I.

The name of the corporation is UNIVERSAL WRESTLING CORPORATION.

II.

The corporation is organized pursuant to the provisions of the Georgia Business Corporation Code.

III.

The corporation shall have perpetual duration.

IV.

The purpose of the corporation is pecuniary gain and profit, and the general nature of the business or businesses to be transacted shall be to organize, manage, stage and promote wrestling matches in arenas and to record, film, tape and distribute wrestling matches via any means, whether now known or hereafter developed, for the transmission and reception of audio and visual signals, including without limitation, all forms of television, satellite television, MDS, MMDS, direct broadcast satellite, basic cable, pay cable, pay per view television, home

video, video disc, laser disc, motion picture and radio and to engage in any and all other activities necessary or incidental to the accomplishment and full exploitation of these purposes; to acquire by purchase or lease or otherwise, lands and interests in lands, whether for investment, resale, or for its own use; to own, hold, improve, develop, and manage any real estate so acquired; to erect or cause to be erected on any lands owned, held or occupied by the corporation, buildings or other structures with their appurtenances; to rebuild, enlarge, alter or improve any buildings or other structures with their appurtenances; to rebuild, enlarge, alter, or improve any buildings or other structures now or hereafter erected on any lands so owned, held, or occupied; to mortgage, sell, lease, or otherwise dispose of any lands or interests in land and in buildings or other structures at any time owned or held by the corporation; to improve, hold, construct, repair, control, manufacture, buy, distribute, sell, lease as lessor or lessee, merchandise, broker, finance, convey and otherwise deal in goods, wares, merchandise and personal and real property of every kind and description; to engage in any form or type of business for any lawful purpose or purposes not specifically prohibited to corporations for profit under the laws of the State of Georgia; and to have all the rights, powers, privileges and immunities which are now or hereafter may be allowed to corporations under the laws of the State of Georgia.

V.

The total number of shares of capital stock which this corporation shall have authority to issue is One Thousand (1000) shares. Of said shares, Eight Hundred (800) shares shall be of a class designated as Class A Common Stock, par value One Dollar (\$1.00) per share (the "Class A Common Stock"), and Two Hundred (200) shares shall be of a class designated as Class B Common Stock, par value One Dollar (\$1.00) per share (the "Class B Common Stock"). Except as hereinafter provided in this Article V with respect to voting privileges, each share of Class A Common stock and each share of Class B Common Stock shall be identical in all respects and shall have equal rights and privileges.

The holders of the Class A common stock shall have exclusive voting power. The holders of the Class B Common Stock shall have no right to vote for any purpose except as otherwise specifically required by applicable law.

VI.

The corporation shall not commence business until it shall have received not less than Five Hundred Dollars (\$500.00) in payment for the issuance of shares of its stock.

VII.

Preemptive rights are hereby denied. No holder of any shares of this corporation shall have the preemptive right to purchase, subscribe for, or otherwise acquire any shares of

stock of the corporation of any class now or hereafter authorized, or any securities exchangeable for or convertible into such shares, or any warrants or other instruments evidencing rights or options to subscribe for, purchase, or otherwise acquire shares.

VIII.

The initial registered office of the corporation shall be One CNN Center, Box 105366, Atlanta, Georgia 30348-5366. The initial registered agent at such address shall be Steven W. Korn.

IX.

The initial Board of Directors shall consist of five (5) members, whose names and addresses are: R. E. Turner, One CNN Center, Box 105366, Atlanta, Georgia 30348-5366; Jack Petrik, One CNN Center, Box 105366, Atlanta, Georgia 30348-5366; Paul D. Beckham, One CNN Center, Box 105366, Atlanta, Georgia, 30348-5366; Steven W. Korn, One CNN Center, Box 105366, Atlanta, Georgia 30348-5366; and James Crockett, 421 Briarbend Drive, Charlotte, North Carolina 28209.

X.

The corporation may, upon adoption of a resolution by its Board of Directors, purchase its own shares to the extent of unreserved and unrestricted capital surplus available therefor.

XI.

The Board of Directors of the corporation may, from time to

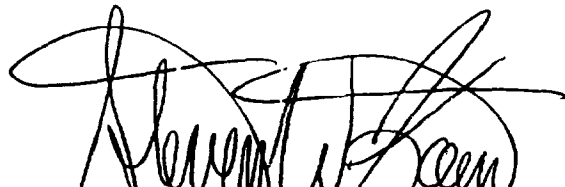
time, in its discretion and without approval by or authorization from the shareholders of the corporation, distribute to the shareholders out of the capital surplus of the corporation a portion of its assets.

XII.

The shareholders of the corporation shall have such rights to take actions by written consent of less than all shareholders as may be permitted by Section 14-2-112(d) of the Georgia Business Corporation Code or as Georgia law may otherwise provide.

XIII.

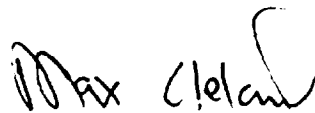
