**ASSIGNMENT**

WHEREAS, SUNBEAM PRODUCTS, INC., a Delaware corporation, having a principal place of business at Sunbeam Corporaate Center, 1615 South Congress Avenue, Suite 200, Delray Beach, Florida 33445 (hereinafter "Assignor"), is the owner of all right, title and interest in and to the registered, pending and/or common law trademarks which are set forth on Schedule A attached hereto (the "Trademarks"); and

WHEREAS, SPRINGFIELD PRECISION INSTRUMENTS, INC., a Delaware corporation, having a principal place of business at 76 Passaic Street, Wood-Ridge, New Jersey 07075 (hereinafter "Assignee"), has acquired said Trademarks through an Assct Purchase Agreement by and among Sunbeam Products, Inc., OP II, Inc. and Springfield Precision Instruments, Inc., signed and dated February 12, 1997 (hereinafter "Agreement").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor, and intending to be legally bound hereby, said Assignor does hereby assign, sell, transfer, set over and quit claim unto said Assignee the full extent of its worldwide right, title and interest in and to the Trademarks and all registrations therefor, together with all the good will of the business symbolized by the Trademarks, including all the rights Assignor has to sue for and collect damages and other recoveries for past infringement thereof.

And for the consideration aforesaid, Assignor agrees that it will, upon request, execute and deliver to Assignee any and all additional papers and generally do all other and further lawful acts deemed necessary by said Assignee to carry out the terms of this Agreement.
