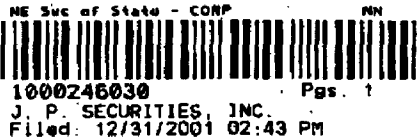

ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
AMERITRADE (INC.)



Pursuant to the provisions of the Nebraska Business Corporation Act, Ameritrade (Inc.), a Nebraska corporation, hereby adopts the following Articles of Amendment to the Articles of Incorporation:

FIRST: The name of the corporation is: Ameritrade (Inc.)

SECOND: Article I of the Articles of Incorporation of the corporation has been amended so as to read in its entirety as follows:

"ARTICLE I.

NAME

The name of the corporation is J. P. Securities, Inc."

THIRD: Such amendment was adopted on the 31st day of December, 2001, and shall be effective as of January 2, 2002.

FOURTH: The designation and number of outstanding shares of the corporation are as follows:

<u>Designation</u>	<u>Number of Outstanding Shares</u>
Common Stock	6,000

The corporation has only one voting group.

FIFTH: Such amendment has been approved by an informal action signed by the Board of Directors of the corporation. Such informal action shall have the same effect as a meeting vote in favor of such amendment by the Board of Directors of the corporation.
