SCHEDULE "A" TO THE ARTICLES OF AMALGAMATION OF
GOODLIFE BRANDS INC.

The right to transfer shares shall be restricted in that no share shall be transferred except with the consent of the board of directors of the Corporation, to be expressed either by a resolution passed at a meeting of the board of directors or by an instrument or instruments in writing signed by a majority of the directors.

Other Provisions, if any:

1. The number of shareholders, exclusive of:

- (a) persons who are in its employment and are shareholders; and
- (b) persons who, having been formerly in the employment of the Corporation, were, while in that employment, shareholders and have continued to be shareholders of the Corporation after termination of that employment;

is limited to not more than fifty (50) persons, two or more persons who are joint registered owners of one or more shares being counted as one shareholder.

2. There shall be no invitation to the public to subscribe for any securities of the Corporation.
