TRADEMARK ASSIGNMENT

This Assignment is made on the 20th day of April, 2002 BETWEEN Electrohome Limited (hereinafter referred to as "Assignor"), an Ontario corporation AND Christie Digital Systems Canada, Inc. (hereinafter referred to as "Assignee") a New Brunswick corporation.

WHEREAS by a Purchase and Sale Agreement between the Assignor and Assignee dated the 23 day of August, 1999, (the "Electrohome Agreement"), the Assignor did assign to the Assignee all of its rights and interests in and to the trademarks listed in Schedule A (the "Trademarks") in the various jurisdictions set out in Schedule A;

WHEREAS the Assignee did not advise the registrar of trademarks in Canada or their local equivalents in the various other national jurisdictions of the assignment of the Trademarks between Assignor and the Assignee pursuant to the Electrohome Agreement;

WHEREAS the Assignor is still shown as the registered owner of the Trademarks on the various national registers of trademarks;

WHEREAS, notwithstanding the various national registers, the Assignee is the beneficial owner of the rights presently existing in the Trademarks;

NOW, THEREFORE, in consideration of and in exchange for the sum of Ten Dollars (\$10.00) in lawful money of Canada and other goods and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. The Assignor, does hereby confirm that they have sold, assigned, and transferred unto the Assignee all of its right, title, and interest in and to the Trademarks to which the Assignor is entitled together with the goodwill of the business symbolized by the said marks and to the goods and services associated with the said marks.
2. The Assignor undertakes to use its best efforts to assist the Assignee in effecting the proper transfer of registration of the Trademarks in the name of the Assignee, and shall, with reasonable diligence, do all such things and provide all such reasonable assurances as may be required to consummate the transactions contemplated by this agreement.

- 3. Each party shall provide such further documents or instruments required by any other party as may be reasonably necessary or desirable to effect the purpose of this agreement and carry out the provisions hereof.
- 4. The parties, upon mutual consent not to be unreasonably withheld, agree to amend Schedule A from time to time as additional information becomes available to either of the parties, and such amended Schedule A shall form part of this agreement as if originally executed.
