WHEREAS:

A. TRUKKE WINTER SPORTS PRODUCTS, INC. E. ASSIGNOR has defaulted on its obligations as secured thereby and ASSIGNEE desires to exercise its remedy thereunder to obtain said patent application and trademark registration from ASSIGNOR; and

F. ASSIGNOR desires to make the within assignments in lieu of formal foreclosure proceedings.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR by these presents does sell, assign and transfer unto ASSIGNEE, its successors, assigns and legal representatives, the full and exclusive right to the invention as described in the aforesaid application (the "Invention"), and to all formal applications which may be filed based in whole or in part on one or more of the aforesaid applications, in the United States and all foreign countries, together with the right of priority under the International Convention for the Protection of Industrial Property, Inter-American Convention Relating to Patents, Designs and Industrial Models, and any other international agreements to which the United States adheres, and hereby authorizes and requests the Commissioner of Patents to issue any Letters Patent issuing from or claiming priority to said application to ASSIGNEE, for the sole use and benefit of ASSIGNEE, its successors, assigns and legal representatives. A "formal application," (or "formal applications") as referred to herein, shall mean any provisional, non-provisional, continuation, continuation in part, divisional, reissue, reexamination, foreign, PCT or other patent application or like document;

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR by these presents does sell, assign and transfer unto ASSIGNEE, its successors, assigns and legal representatives, the entire right, title and interest in and to the Trukke name and in and to said Trademark Registration Number 2,061,751 and any renewals, extensions, continuations, and reissues thereof, or like document, and in and to all trademarks and icons based upon, derived from, used in conjunction with, or incorporating the Trukke name, and in and to all income and royalties with respect thereto, and in and to all rights corresponding to the foregoing throughout the world.


Upon the request of ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, ASSIGNOR agrees to:
