Pursuant to the provisions of Nevada Revised Statutes ("NRS") 92A.100 and 92A.200, the undersigned, as the Secretary of each of Travelscape.com, Inc., a Nevada corporation (the "Surviving Constituent Entity"), and Travelscape.com, Inc., a Delaware corporation (the "Merging Constituent Entity"), in order to effectuate the merger of the Merging Constituent Entity into the Surviving Constituent Entity, hereby certifies as follows:

1. The name of each constituent corporation to this merger and the jurisdiction of its organization are as follows:

- (a) the Surviving Constituent Entity: Travelscape.com, Inc., whose jurisdiction of organization is the State of Nevada. and
- (b) the Merging Constituent Entity: Travelscape.com, Inc., whose jurisdiction of organization is the State of Delaware.

2. A plan of merger has been adopted by each constituent entity.

3. The plan of merger was submitted to the stockholders of each constituent entity and approved by the unanimous consent of such stockholders.

4. The Articles of Incorporation of the Surviving Constituent Entity are hereby amended as follows:

Article I of the Articles of Incorporation of the Surviving Constituent Entity is amended to read in its entirety as follows:

"ARTICLE I

6. A copy of the plan of merger will be furnished by the Surviving Constituent Entity on request and without any cost to any stockholder of any constituent entity.

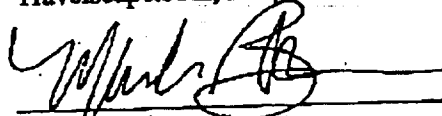
7. The effective date of this merger is the date upon which these Articles of Merger are filed in the office of the Secretary of State of Nevada.
