## TRANSLATION

I, the undersigned, Luis Eduardo González Abreu, holder of Identity Card N° 4.356.156, a certified Public Interpreter in and for the Republic of Venezuela in the English language as evidenced by license published in the Official Gazette of the Republic of Venezuela N° 35.497, dated July 7, 1994, registered at the Main Office of the Public Registry of the Federal District under number 157, Folio 157, Volume 6 of the Sole Protocol, and at the First Court of First Instance for Family and Minors for the Judicial Circuit for the Caracas Metropolitan Area, on May 17, 1994, hereby certify that the following is a true translation of the attached Spanish document, which I have been asked to translate: "ASSIGNMENT AGREEMENT. I, Antonella Sciubba, Venezuelan, of legal age, married, of this domicile and holder of Identity Card N° 11.551.741, acting for and on behalf of LEBLON INVESTMENTS LIMITED, a corporation domiciled in the Cayman Islands, registered with the Registrar of Companies of The Cayman Islands, B.W.I., on September 21<sup>st</sup>., 1990, under N° 374249, which capacity is evidenced from a power of attorney duly authenticated before the Third Notary Public's Office of the Sucre Autonomous Municipality of the State of Miranda, dated July 16, 1999, under number 79, Volume 82 of the respective authentication books, hereby declare: That in the name of my principal, in a pure, simple, perfect and irrevocable manner, I assign to MAVESA, S.A., a corporation domiciled in Caracas, Bolivarian Republic of Venezuela, recorded with the Commercial Registry kept by the Court of First Instance in Mercantile Matters of the Federal District, dated May 19, 1949, under N° 552, Volume 2-B, all of the rights over the trademarks and/or distinctive signs owned by my principal and to which it is entitled to, listed in the Schedule marked "A", which, having been signed by both parties, has been made an integral part hereof, and which rights constitute 50% of the undivided rights over said trademarks and/or distinctive signs contained in the said Schedule "A", whereas the remaining 50% of the undivided rights belonging in joint ownership to GERBER PRODUCTS COMPANY or to

GERBER VENEZUELAN HOLDING COMPANY, INC.; as well as all the rights with respect to administrative actions that may have been exercised or are being exercised on the same and the litigation rights exercised before any forum or instance. Moreover, I declare that my principal does not own any other trademarks identical or similar to the ones being assigned herein; but if so, they shall likewise be considered assigned between the parties, by this same document and by the price indicated below. The price of the assignment is the amount of two hundred U.S. dollars (US\$200.00) for each trademark, which is hereby received in cash for my principal to my complete satisfaction. For the sole purpose of complying with the Law of the Central Bank of Venezuela, the amount of two hundred U.S. dollars (US\$200.00), is equivalent to the amount of one hundred forty-six thousand and fifty bolivars (Bs. 146,050.00) at the exchange rate of seven hundred and thirty bolivars with twenty-five cents (Bs. 730.25) per dollar, effective on the 21<sup>st</sup> of August, 2.001. Likewise, my principal declares that there are no legal proceedings or encumbrances whatsoever on the assigned trademarks and/or distinctive signs listed on the Schedule marked "A". With the granting of this document, my principal makes legal delivery of the assigned trademarks and/or distinctive signs and undertakes to warrant title, as required by Law. And I, Pablo Baraybar, Peruvian, of legal age, married, domiciled in Caracas, Bolivarian Republic of Venezuela, holder of Identity Card N° E-82.238.059, acting in my capacity as Executive President of MAVESA, S.A., above identified and duly authorized herefor, as evidenced from item Fourth of the Minutes N° 674 of the Company's Board of Directors dated July 31, 2001, hereby declare: That I accept, in favor of my principal, MAVESA, S.A., the above mentioned assignment in the terms set forth herein. In Caracas, on the 24<sup>th</sup> day of the month of August, 2001.
