

BETWEEN:

- (1) WHITBREAD PLC of Chiswell Street, London, EC1Y 4SD (the "Assignor"); and
- (2) BRANDBREW SA of L-Rue Goethe 11BP 1107, Luxembourg (the "Assignee").

WHEREAS:

- (A) The Assignor is the owner and is or is entitled to be registered as the proprietor of the Trade Marks.
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee.

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. INTERPRETATION

- 1.1 In this Agreement, the following expression shall have the following meaning:

2. ASSIGNMENT

In consideration of the payment of £15,999,988 from the Assignee to the Assignor (receipt of which is hereby acknowledged by the Assignor), the Assignor hereby assigns to the Assignee all its right, title and interest in and to the Trade Marks and all rights, privileges and advantages thereto, including without limitation all rights to bring any proceedings and obtain any remedy in respect of any infringement of the Trade Marks which has occurred prior to the date of this Agreement to hold unto the Assignee, its successors and assigns absolutely.

3. FURTHER ASSURANCE

The Assignor shall, at the request of the Assignee, execute any further documents that may be reasonably necessary to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder and to ensure that the Assignee is registered as the registered proprietor of the Trade Marks with any relevant trade marks registry.

4. GOVERNING LAW

This Assignment shall be governed by and construed in accordance with English law and the parties hereby submit to the exclusive jurisdiction of the English Courts in relation to all matters arising out of this Assignment.
