## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release granted as of February 11, 2002, by Bankers Trust Company, a New York banking corporation, as Collateral Agent (the "Agent"), with principal offices at 31 West 52<sup>nd</sup> Street, New York, New York 10019, to Phase Separations, Inc., a Connecticut corporation ("Assignor"), with principal offices at 20 Liberty Way, Franklin, Massachusetts 02038, as follows:

### W I T N E S S E T H:

WHEREAS, the Assignor has heretofore granted to the Agent a security interest in certain U.S. trademarks, trademark applications and trademark registrations, as more particularly set forth on Schedule A attached hereto (the "Marks"), to secure the Obligations (as defined in the Security Agreement dated November 22, 1995, between the Agent and the Assignor (the "Security Agreement")), which security interest was duly recorded on February 22, 1996 at Trademark Reel 1456, Frame 0702 in the United States Patent and Trademark Office (the "Security Interest"); and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Marks to the Assignor and to dissolve any and all Liens and encumbrances respecting the Marks shown on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all right, title and interest in and to the Marks, and more particularly, (i) the Security Interest in the Marks, (ii) all Proceeds (as such term is defined in the Security

Agreement) and products of the Marks, (iii) the goodwill of the business symbolized by the Marks and (iv) all causes of action arising prior to or after November 22, 1995 for infringement of any of the Marks or unfair competition regarding the same, and granted to the Agent by the Assignor by the Security Interest.
