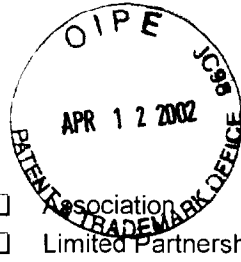



THIS DEED OF ASSIGNMENT is made the day of 1996

BETWEEN

- (1) **SW INDUSTRIES JNC** a company incorporated under the laws of the State of Delaware and whose address is 1075 Everie Inn Road, Griffin Georgia 30223 (hereinafter "the Assignor")

AND

- (2) **BEFORENOVEL LIMITED** (registered number 3245099) whose registered office is at Woodson House, Ajax Avenue, Slough, Berkshire, SL1 4DJ (hereinafter "the Assignee").

WHEREAS

- (A) The Assignor is the proprietor and beneficial owner of the trade mark registrations (the 'Trade Marks') set out in the Schedule hereto.
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out below.

NOW IT IS HEREBY AGREED as follows:-

1. In consideration of the sum of £1 (one pound sterling) now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges) the Assignor hereby assigns to the Assignee all its right title and interest in and to the Trade Marks (including any renewals and extensions that may be granted thereof) together with the goodwill attaching to and symbolised by the Trade Marks and together with all rights of action remedies, powers and benefits relating to the Trade Marks belonging or accrued TO HOLD unto the Assignee absolutely.

2. At the request and expense of the Assignee the Assignor shall provide all reasonable assistance which the Assignee considers necessary in connection with bringing or defending any proceedings relating to any of the rights assigned by Clause 1 hereof.
3. The Assignor undertakes that at the request and expense of the Assignee it will do all acts and things and execute all documents, papers, forms and authorisations or do any other thing that may be reasonably necessary under the law of any country for securing, completing, further assuring or absolutely vesting in the Assignee full right, title and interest to any of the rights assigned by Clause 1 hereof.
4. This Assignment (together with all documents referred to herein) shall be governed by and construed and shall take effect in accordance with English law.
