
ASSIGNMENT OF TRADEMARK

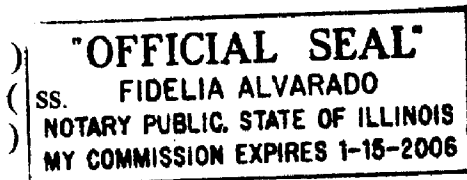
