## TRADEMARK ASSIGNMENT

**TRADEMARK ASSIGNMENT** ("Assignment") made as of June 24, 2002, by and among Selkirk, Inc., a Delaware Corporation with offices at 14801 Quorum Drive, Dallas, Texas 75254 ("Assignor") and Selkirk L.L.C., a Delaware limited liability corporation with offices at 14801 Quorum Drive, Dallas, Texas 75254 ("Assignee").

**WHEREAS**, pursuant to a Stock and Asset Purchase Agreement dated as of May 17, 2002 (the "Purchase Agreement"), by and among U.S. Industries, Inc., Eljer Plumbingware, Inc., Selkirk, Inc., Selkirk Canada U.S.A., Inc., Selkirk Canada, Inc., Selkirk Acquisition Partners and Tincum Capital Partners, L.P., Assignor agreed to sell, convey, transfer and assign, or cause to be sold, conveyed, transferred and assigned to Assignee all its right, title, and interest in certain trademarks, service marks, trade names, corporate and business names, brand names, Internet domain names, universal resource locators, designs, logos, trade dress, slogans, and general intangibles of like nature, including the Selkirk Rights in the Mutual Territory (as such capitalized terms are defined in the Intellectual Property Co-Existence Agreement between Assignor and Selkirk Europe Limited dated November 17, 2000) together with all goodwill, registrations and applications relating to the foregoing, including but not limited to those set forth on SCHEDULE A, (collectively, the "Trademarks").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign to Assignee, its successors, assigns and legal representatives, its entire right, title and interest in and to the Trademarks, and the right to bring an action at law or in equity and collect damages for the infringement or other impairment of the foregoing or to oppose an Application for registration of a trade mark which may be confusing with any one of the Trademarks.

Assignor further covenants and agrees that it will, without further consideration, promptly file for recordation in the appropriate intellectual property registries, all documents necessary to bring record ownership of the Trademarks into the name of the current owner thereof and provide to Assignee, the necessary information and original registration certificates to permit Assignee to effect and perfect the transfer of the Trademarks.
