THIS TRADEMARK ASSIGNMENT is made this 30th day of June, 1995 by Witco Corporation, successor by name change to Witco Chemical Corporation, ("Assignor"), a Delaware corporation with its principal place of business at One American Lane, Greenwich, Connecticut 06831.

WHEREAS, Assignor has entered into an Asset Purchase Agreement, dated May 25, 1995 (the "Agreement") between Assignor, an affiliate thereof and China Synthetic Rubber Corporation, a Republic of China corporation ("CSRC"); and

WHEREAS, CSRC has assigned its rights under the Agreement to Concarb Acquisition Corp., a Delaware corporation with its principal place of business at 10500 Richmond Avenue, Houston, Texas 77242 ("Assignee"); and

WHEREAS, Assignee desires to acquire all of Assignor's right, title and interest in, to and under said Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee, its successors, legal representatives and assigns, all of Assignor's right, title and interest in and to the Trademarks together with the goodwill of the business associated with said trademarks and registrations thereof (including, without limitation, all proceeds thereof and the rights to sue for past, present and future infringements), the same to be held and enjoyed by Assignee, for its own use and on behalf of its successors, legal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor, had this sale and assignment not been made.

Assignor hereby requests the Commissioner of Patents and Trademarks to record Assignee, as assignee of the trademark

registrations and applications for registration listed on Schedule A, for the sole use and enjoyment of Assignee, its successors, legal representatives and assigns.
