1. They are the President and Secretary, respectively, of SecurityFocus.com, a California corporation.

2. Article I of the Articles of Incorporation of this corporation is hereby amended to read in its entirety as follows:

The name of the corporation is SecurityFocus.


3. The foregoing amendment of Articles of Incorporation has been duly approved by the board of directors.


4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation is 6,938,900 shares of Common Stock, and 11,641,504 shares of Preferred Stock, consisting of 3,300,000 shares of Series A Preferred Stock, 1,500,000 shares of Series B Preferred Stock and 6,841,504 shares of Series C Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the shares of Common Stock, Series A Preferred Stock, Series B Preferred Stock and Series C Preferred Stock, voting together as a single class on an as-converted basis, and more than 50% of the shares of Series C Preferred Stock, voting as a single class.
