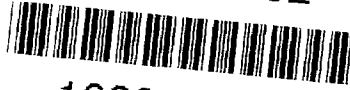




45(b)(1) Declar. Ownership
