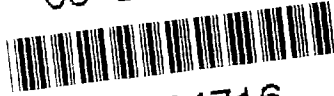

WHEREAS, Wells Fargo desires to fully release any and all claims it may have in the Marks, including the Security Interests.

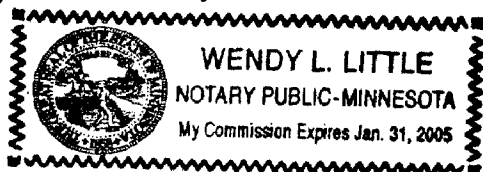
