RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST dated May 15, 2002 ("Release") is made by Comerica Bank, as successor agent to The Fifth Third Bank, acting in its capacity as Secured Party and Agent for certain Banks (in such capacity, the "Secured Party") under the AMENDMENT NO. 3 TO TRADEMARK AGREEMENT dated January 3, 2000, as amended or modified and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 2061, Frame 208 (the "Trademark Agreement"), among Consolidated Biscuit Co. (together with its affiliated companies, the "Debtor") and the Secured Party.
