TRADE MARK ASSIGNMENT

DATE: 30 September 1998

PARTIES:

- (1) **CEDEL INTERNATIONAL S.A.** a company incorporated in Luxembourg with limited liability whose principal place of business is at 67 Boulevard Grande-Duchesse Charlotte, L-1331 Luxembourg (the "Assignor") and
- (2) **REUTERS LIMITED** (registered no. 145516) whose registered office is at 85 Fleet Street, London EC4P 4AJ (the "Assignee").

BACKGROUND

- (A) The Assignor is the registered proprietor of the trade marks and is the applicant in respect of the trade mark applications details of which are set out in the Schedule (the "Trade Marks").
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out below.

IT IS NOW AGREED THAT:

1. INTERPRETATION

- 1.1 The index and headings are included for convenience only and shall not affect the interpretation or construction of this Agreement.
- 1.2 References to Clauses or the Schedule are to clauses of or the schedule to this Agreement.
- 1.3 References to any of the masculine, feminine and neuter genders shall include the other genders and references to the singular number shall include the plural and vice versa.
- 1.4 References to a document are to that document as varied, supplemented or replaced from time to time.
- 1.5 References to writing shall include any modes of reproducing words in a legible and non-transitory form.

2. ASSIGNMENT

In consideration of the sum of One Pound Sterling (£1) now paid by the Assignee to the Assignor (the receipt of which the Assignor now acknowledges) the Assignor **HEREBY ASSIGNS** to the Assignee as beneficial owner with full title guarantee all right, title and interest in and to the Trade Marks, including all statutory and common law rights and all goodwill in the Trade Marks, free from all liens charges and encumbrances, **TO HOLD** unto the Assignee absolutely. The rights so assigned include the right to sue for, and to recover any damages and other remedies in respect of, any infringement of the Trade Marks and any passing off in relation to the Trade Marks which occurred or commenced prior to the date of this Agreement.

3. FURTHER ASSURANCE

- 3.1 The Assignor will at the Assignee's request do all acts and execute or procure the execution of all documents as may be required properly for giving full effect to the assignment contained in Clause 2 (Assignment).
- 3.2 The Assignor will do everything reasonably in its power to assist the Assignee in the defence of any proceedings for cancellation or revocation of any or all of the Trade Marks or of any oppositions to any applications in respect of any or all of the Trade Marks. The Assignee agrees to reimburse the Assignor for all expenses reasonably incurred by the Assignor in doing so.
- 3.3 As soon as reasonably practical following the date of this Agreement the Assignor shall transfer possession of all files and records relating to the Trade Marks to the Assignee. The Assignor shall pass all correspondence and documents which it may receive relating to the Trade Marks to the Assignee.

4. JURISDICTION

This Agreement shall be construed in accordance with English law and the parties irrevocably submit to the exclusive jurisdiction of the English courts to settle any disputes which may arise in connection with this Agreement.

EXECUTION:

The parties have shown their acceptance of the terms of this Agreement by executing it after the Schedule.


