## TRADEMARK ASSIGNMENT AGREEMENT

Agreement made this 22nd day of October, 2001, by and between INTRUST BANK, N.A., a corporation organized under the laws of the State of , having its principal place of business at Box One, Wichita, Kansas 67201 (hereinafter referred to as "Assignor"), and KEOKUK SAVINGS BANK & TRUST, a corporation organized under the laws of the State of Iowa, having its principal place of business at 501 Main Street, Keokuk, Iowa 52632 (hereinafter referred to as "Assignee").

### RECITALS

A. Assignor is the owner of the trademark "KSB" as used to identify general banking services (the "Mark"), including United States Trademark Registration No. 1,003,023 which issued January 28, 1975, and the goodwill associated with the Mark.

B. Assignee is interested in acquiring all of the rights of Assignor in the Mark, including the trademark registration and goodwill associated with the mark.

In consideration of the foregoing, and for other good and valuable consideration, the parties hereto agree as follows:

1. Assignment of Trademark In consideration of Five Hundred Dollars (\$500.00) to be paid to Assignor upon execution of this Agreement, Assignor hereby assigns and transfers to Assignee the entire right, title and interest in and to the trademark "KSB" in all forms and the goodwill of the business in connection with which such mark is used. Assignor also hereby assigns and transfers to Assignee all trademark registrations owned by Assignor on the Mark as listed on Exhibit A attached to this Agreement and made a part hereof by this reference.

2. Responsibility for Expenses Assignee shall be responsible, at its own expense, for the preparation, legalization and recording of any documents which may be necessary to effect and record the assignment of the trademark rights and registrations under this Agreement, and Assignor hereby appoints Assignee as Assignor's attorney-in-fact, irrevocably and coupled with an interest, to execute, acknowledge, deliver and record any documents or instruments necessary to effect such assignment. Assignor shall be responsible for its own attorney's fees and any other expenses incurred by it in carrying out its obligations under this Agreement.

3. Assistance of Assignor Assignor will assist Assignee in obtaining any information or documents in the possession or control of Assignor that may be necessary or helpful to Assignee in giving effect to this assignment and agreement.
