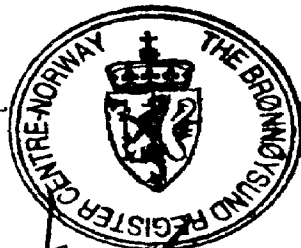
**STOKKE FABRIKKER AS**, organization number 934 215 966 was transferred to the Register of Business Enterprises on 20 April 1990.

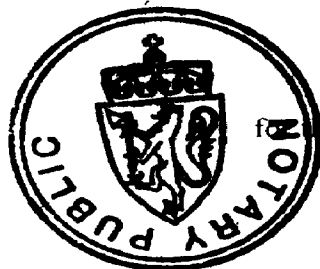
As a result of the merger, notification was given that **STOKKE FABRIKKER AS** was struck off the Register of Business Enterprises on 19 October 2000.




