Dear Ms. Brantley:

This letter serves as an explanation of the change in title for your institution from Old National Bank in Evansville, Evansville, Indiana, to Old National Bank, Evansville, Indiana.

On December 11, 1998, correspondence related to a multi-bank merger approved by the OCC involving your bank was sent by this office reflecting the bank's former name. However, the submission of the bank's requisite documents effecting the change in title was received by this office after December 11, 1998, the date indicated on the cover letter and within the accompanying documents. Thereafter, additional OCC correspondence related to the same merger reflected the new title of the bank due to updating of our records to reflect the change.

Therefore, the OCC's records reflect the name of your institution as Old National Bank, located in Evansville, Indiana, with an effective date of December 11, 1998.
