TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") made as of the 20th day of April, 2002 by and between Siemens Corporation, a Delaware company, having a principal business address of 153 East 63rd Street, New York, New York 10022, USA ("ASSIGNOR"), and Unisphere Networks, Inc., a corporation of Delaware, having its principal place of business at 10 Technology Park Drive, Westford, Massachusetts, USA ("ASSIGNEE").

WITNESSETH:

WHEREAS, ASSIGNOR is the owner of trademarks, service marks, logos and any and all trade dress associated therewith for the "Unisphere" marks ("the Marks"), as described in Exhibit A attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby in connection with the products on which the Marks are used ("the Products"); and

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Marks in both the United States of America and in any foreign countries not listed in Exhibit A in which the Marks are registered or pending (the "Worldwide Rights in the Marks").

NOW, THEREFORE, ASSIGNOR and ASSIGNEE, in consideration of the mutual agreements herein contained and for other good and valuable consideration, acknowledged by each of them to be satisfactory and adequate, do hereby agree as follows:

Section 1

ASSIGNMENT

1.1 For \$1,000,000, the receipt and sufficiency of which are hereby acknowledged as good and valuable consideration, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest in and to the Marks and the Worldwide Rights in the Marks, together with (1) the goodwill of the business relating to the Products in respect upon which the Marks and Worldwide Rights in the Marks are used and for which they are registered; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks and Worldwide Rights in the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks and Worldwide Rights in the Marks; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Marks and Worldwide Rights in the Marks.
