
TRADEMARK ASSIGNMENT

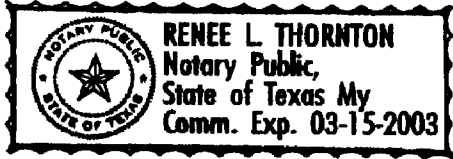
