BELTZ & RUTH, P.A.

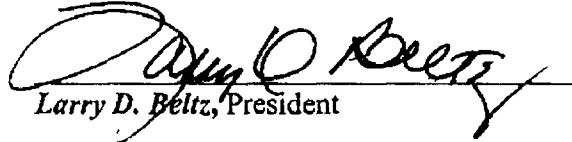
