
LMC hereby assigns and transfers to LMC all of its right, title and interest in and to the mark identified on **Schedule A** attached hereto and made a part hereof, and to the unregistered marks SPACE DAY and CYBER SPACE DAY (the "Marks"), together with all the good will which is or will be symbolized by the said Marks, and all rights and privileges under each of the Marks, including the right to renew and/or register each of the Marks anywhere in the world, and all rights to recover for damages and profits for infringement in the United States and throughout the world.

LMC agrees to terminate promptly any license agreements with third parties that permit them to use the Marks; provided that any such agreements that cannot be terminated are hereby assigned to the Foundation in whole or in part, to the extent they authorize third parties to use the Marks as well as other marks of LMC.


The Foundation hereby accepts such assignment and transfer.
