ASSIGNMENT OF TRADEMARKS

duty it is to record trademark registrations, applications and title, thereto, to record this ASSIGNMENT OF TRADEMARKS against the TRADEMARKS and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns; and

ASSIGNOR, further agrees to execute such further documents as may be required in countries foreign to the United States to record ASSIGNEE as the owner of the TRADEMARKS and the registrations and applications herein assigned.
