IN WITNESS WHEREOF, Assignor has executed this Assignment as of the date first above written.

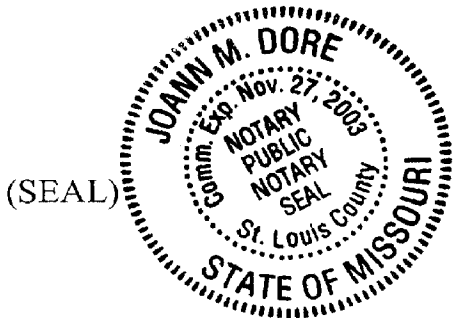
