## ASSIGNMENT OF TRADEMARKS

WHEREAS **U.S. AID, INC.**, a North Carolina corporation, with its principal office located at 122 Armstrong Street, Gastonia, North Carolina 28054 (“Assignor”), has adopted, used, and is using the trademarks listed on Exhibit A attached hereto which are registered in the United States Patent and Trademark Office (the “Marks”) in connection with various first aid supplies; and

WHEREAS, **UNIFIRST CORPORATION d/b/a GREEN GUARD FIRST AID & SAFETY SERVICE**, a Massachusetts corporation, with its principal office located at 68 Jonspin Road, Wilmington, Massachusetts 01887 (“Assignee”), is desirous of acquiring all right, title and interest in and to said Marks, along with the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, by these presents, does hereby sell, assign, and transfer unto Assignee all of its right, title, and interest in and to the Marks, together with the goodwill of the business symbolized by said Marks, the same to be held and enjoyed by Assignee, for its own use and benefit and that of its successors and assigns, to the full end of the term for which said Marks are granted, together with all claims for damages by reason of past infringement of said Marks, with the right to sue for and collect the same for its own use and for the use of its successors, assigns, or other legal representatives.

Assignor does hereby covenant and warrant that: (i) it is the owner of said Marks and has full right and title thereto and authority to sell, assign, and dispose of the same; (ii) it has not granted any right or license to use the Marks to anyone; (iii) prior to execution of this deed, Assignor’s right, title, and interest in said Marks has not been otherwise encumbered; and (iv) it has not executed, and will not execute, any instrument in conflict herewith.
