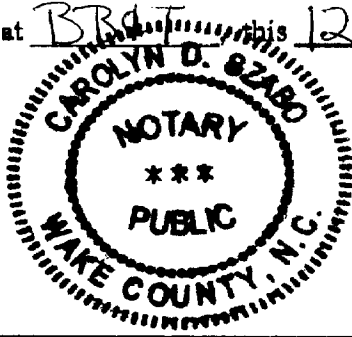

This Assignment will be interpreted and governed by the US Federal laws governing trademarks and the laws of the State of North Carolina; any dispute requiring legal resolution will be held within the legal systems of the State of North Carolina, either Federal or State venues, as appropriate.

Furthermore, the parties hereto desire that this Assignment document be recorded with the US Patent and Trademark Office upon execution hereof.
