

FIRST: They are the duly elected and acting President and Secretary, respectively, of BTX, Inc., a California corporation (the "Corporation").

SECOND: Article I of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

I.

The name of the Corporation is Genetronics, Inc.


THIRD: The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors.

FOURTH: The foregoing amendment has been duly approved by the required vote of the shareholders of the Corporation in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the Corporation is 500,000 shares of Common Stock and 130,000 shares of Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the outstanding capital stock of the Company voting together on an as-converted to Common Stock basis.

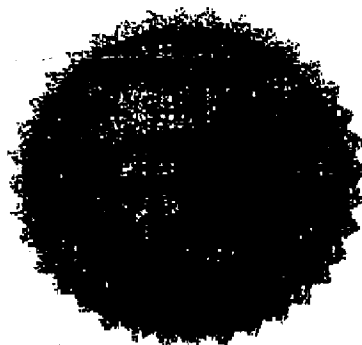
