

Re: Acquisition of Assets from Guardian Safety Barrier

Dear Mr. Boghossian:

This firm represented Armorcast Products Company, a California corporation ("Armorcast"), with respect to the acquisition of substantially all of the assets owned or used by Guardian Safety Barrier, a Nevada corporation ("Guardian"), in connection with Guardian's safety barrier business (the "Assets"). The Assets were acquired on October 27, 2001 pursuant to the terms of an Agreement of Sale dated as of October 27, 2001 between Armorcast and Guardian (the "Agreement").

We have attached hereto a copy of the Agreement. Sections 2 and 11 of the Agreement specify the Assets to be acquired by Armorcast. Section 4 of the Agreement provides that Armorcast does not assume, acquire or take over any liabilities or obligations or any kind of Guardian. Section 1(b) provides, in the form of a representation and covenant of Guardian, that Guardian is the legal owner of the Assets, free and clear of any and all liens, other than the lien securing a loan made by Black Mountain Community Bank which was to be repaid with a portion of the transaction proceeds. Section 2(c) requires Guardian to execute appropriate assignments, transfers or other documents necessary to transfer the Assets to Armorcast.
