TRADEMARK RELEASE

This Release granted as of June 26 , 2002 by Deutsche Bank Trust Company Americas (formerly known as Bankers Trust Company), as Collateral Agent (the "Agent"), with principal offices at 130 Liberty Street, New York, New York 10006, to Elgar Electronics Corporation, a California corporation ("Assignor"), with principal offices at 9250 Brown Deer Road, San Diego, California 92121, as follows:

W I T N E S S E T H:

WHEREAS, the Assignor has heretofore granted to the Agent a security interest in certain U.S. trademark registrations and U.S. trademark applications, as more particularly set forth on Schedule A attached hereto (the "Marks"), to secure the Secured Obligations (as defined in the Security Agreement, dated February 3, 1998, and amended and restated as of May 29, 1998 and as further amended from time to time, the "Security Agreement.").

WHEREAS, the Agent wishes to release, relinquish and discharge its security interest in and to the Marks to the Assignor and to dissolve any and all Liens and encumbrances respecting the Marks shown on the attached Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Assignor its security interest in (i) the U.S. trademark registrations and U.S. trademark applications, as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement) and products of the Marks, (iii) the goodwill of the business symbolized by the Marks and (iv) all causes of action arising prior to or after February 3, 1998 for

infringement of any of the Marks or unfair competition regarding the same, and granted to the Agent by the Assignor by the Security Agreement, which Assignment was duly recorded on December 19, 2001 at Trademark Reel 2413, Frame 0255 in the United States Patent and Trademark Office.
