TRADEMARK ASSIGNMENT OF SECURITY

WHEREAS, Morlite Systems, Inc., a corporation formed under the laws of Pennsylvania, located at 1805 Pittsburgh Avenue, Erie, PA 16502 ("Borrower"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

Borrower expressly acknowledges and affirms that the rights and remedies of Agent and Lenders with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.


