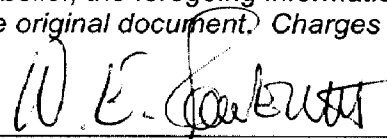

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
WILSHIRE CELLULAR, INC.

The undersigned hereby certify as follows:

1. They are the President and Secretary, respectively, of Wilshire Cellular, Inc., a California corporation.

2. Article I of the Amended and Restated Articles of Incorporation of this corporation is hereby amended to read as follows:

The name of the corporation is Ascendent Telecommunications Inc.

3. The foregoing amendment to the Articles of Incorporation of the corporation has been duly approved by the board of directors.

4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California General Corporation Law. The total number of outstanding shares of common stock and preferred stock of the corporation is 11,605,300 and 80,525, respectively. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%).

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.

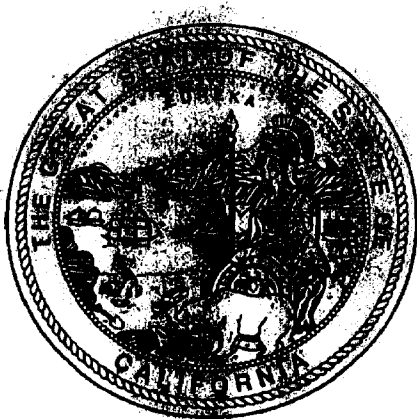
