TRADEMARK ASSIGNMENT

THIS AGREEMENT, by and between TRIDAIR INDUSTRIES, a California corporation, having its principal offices at 3000 West Lomita Blvd., Torrance, California 90505 (hereinafter referred to as "TRIDAIR"), and REXNORD INC., a Wisconsin corporation, having its principal offices at 350 North Sunny Slope Road, Brookfield, Wisconsin 53005 (hereinafter referred to as "REXNORD"),

W I T N E S S E T H :

WHEREAS, TRIDAIR has adopted, used and as of the effective date of this Assignment was using certain trademarks for which TRIDAIR has applied for, obtained and/or acquired by assignment U.S. and foreign trademark registrations, which trademarks, applications for registration and registrations are listed on the attached "Trademark Schedule" and hereinafter collectively referred to as the "Trademarks"; and

WHEREAS, TRIDAIR wishes to sell, and REXNORD has agreed to acquire the business to which the Trademarks relate, along with the appurtenant goodwill thereto and the Trademarks used by TRIDAIR to symbolize said goodwill and identify the source of its products;

NOW, THEREFORE, pursuant to the Agreement and Plan of Liquidation dated November 2, 1981, wherein good and sufficient and valuable consideration is set forth, receipt of which is hereby acknowledged, TRIDAIR has agreed, and does hereby retroactive as of November 2, 1981 agree as follows:

TRIDAIR does hereby assign to REXNORD all right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks.

TRIDAIR further covenants and agrees to execute and cause to be executed, at the request of REXNORD or its successors, assigns or other legal representatives, all assignments, powers of attorney, and other papers as may be reasonably necessary to

enable REXNORD to obtain or maintain the Trademarks herein conveyed or intended to be conveyed. TRIDAIR hereby warrants that it quitclaims any and all interest in the Trademarks and has not made and will not make any commitment or claim inconsistent with or in derogation of this quitclaim.

IN WITNESS WHEREOF, this Assignment having effect nunc pro tunc as of December 31, 1986 has been duly executed on this 27th day of April, 1987.
